OPEN LETTER

RE: Usage of office space in house of Israel Church building

Greetings:

As you may recall, I hand-delivered my letter to you (copy enclosed) regarding the above referenced subject along with the "*floor plan*" drawing of the office space you had requested on or about May 4th, 2009, and we had a discussion about it at that time.

As I recall, I was to find out what sort of lease agreement, if any, there was between the building's owner and Robert James Fox to make use of the office space Robert used in the building.

Unfortunately, I erroneously presumed there was a lease agreement between Mr. Fox and the owner or other person in control of the building, as is usually the case with other buildings and rented or leased office space. However, this situation and circumstance is unique and completely different than anything I am familiar with.

I have since communicated with Mr. Fox, and with the man currently in apparent temporary charge of the building through some type of a corporate sole arrangement with which I was not, and still am not sufficiently knowledgeable to address accurately.

According to Mr. Fox, there never was any type of lease agreement between him and Dr. Barry Eugene Brooks, DDS, the founder of the house of Israel Church, who at the time Mr. Fox was permitted to make use of the office space in the building, was, as I understand it, the owner, or man in control of the building; Mr. Fox was simply allowed to be there as the guest of Dr. Brooks from day-to-day, or until Dr. Brooks decided he didn't want him to be there anymore.

I have not yet been able to communicate with Dr. Brooks, now in prison and near 70 years old regarding the matter, as he was temporarily transferred to another facility for medical treatment.

As I understand it, but I am not exactly certain about it, either prior to, or when Dr. Brooks ended up in prison for allegedly practicing dentistry without renewing his license to do so, someone acting in his behalf other than Mr. Fox arranged a tax exempt

corporate sole in which the building was placed in the best interest of Dr. Brooks, pending his eventual discharge from prison, and it was apparently understood that Mr. Fox was permitted to continue maintaining his office in his designated section of the building, just as the Bell Finance Company was permitted to maintain its apparent lease for its section of the building.

It is my understanding that Dr. Brooks believed that his dental work performed on those who came to him was doing the work of our Creator/Savior, sharing the Gospel, ministering to them, and bringing healing to the body, which is the temple of the Holy Spirit, which, being a purely religious function, did not require that he be licensed by the State, which, I think, explains why he did not renew his license to practice commercial dentistry for profit or gain.

Interestingly, Dr. Brooks, in over 35 years of doing such dental work, never had a single complaint from any of his patients. I was told by several people who know him personally that he is a very good dentist and that quite frequently, he would do such work without payment for those who could not afford to pay him in full, charge reduced fees, and accept barter, or small payments, or, in some cases, in compassion for his fellow man, no payment. It has been made clear to me that Dr. Brooks has always been a very beneficial presence in society and it is a terrible shame the City of Jacksonville Police, District Attorney, Elmer C. Beckworth, Jr., and District Court Judge, Bascom W. Bentley III went to such extremes to put such a good man in prison for eight years at public expense, when no better, more benevolent man ever set foot on the sidewalks of the City of Jacksonville, Texas. It was other local dentists who complained because of selfishness, greed or animus, not because Dr. Brooks did anything wrong. The morons and overly intrusive, abusive predatory, parasitic public servants fail to see they have not harmed Dr. Brooks so much as they have harmed all the hundreds—more likely thousands of people Dr. Brooks cared for and ministered to in his great compassion in service to our Creator/Savior.

At that time, Mr. Fox was legally blind, and he and Dr. Brooks were very close friends with similar beliefs, and often fellowshipped together, which may have had something to do with it. In my experience with Robert James Fox, I have found him to be equally as compassionate and benevolent toward his fellow man, particularly those who are being, and have been unlawfully subjected to government abuse or oppression by insolent, disobedient public servant usurpers such as the City of Jacksonville Police and incompetent and corrupted officers of the Cherokee County Courts have proven themselves to be in this matter, and in other cases.

In my first letter regarding this matter, in my erroneous presumption, I mistakenly stated that Robert Fox was “...*acting as a caretaker...*,” of the building in Dr. Brooks’ absence, when, in fact, he was not ever actually appointed by Dr. Brooks or anyone else to be such a caretaker. Thus, because of my publicly stated erroneous presumptive conclusion, my dear friend and brother in Christ, Robert James Fox was falsely charged with illegal possession of drugs consisting of the dental medications in the dental clinic he knew absolutely nothing whatsoever about, and had no control over whatsoever, once again demonstrating the extraordinary lengths the City of Jacksonville Police under the leadership of sycophant liar, Reece Daniel, and corrupt officers of the Cherokee County Courts will go to destroy totally innocent people they deem to be

socially, politically, or religiously repugnant according to their own arbitrary and capricious standards, under color of law, using the police gun just as was done in Nazi Germany and in Communist Soviet Russia.

As I told you, all of this happened before I came to visit and work with Mr. Fox, so I have no first-hand, personal knowledge of anything that took place prior to my arrival around the middle of September, 2007 when I began working with Mr. Fox, and traveling back to Missouri once or twice each month.

As things stand now, Mr. Fox is still held in jail on a facially fatally defective charge, which is certain to be dismissed, whereupon he will be able to speak directly to you regarding this matter. He is also facing the aforesaid totally ridiculous drug possession charges for alleged possession of the basically worthless dental antibiotics that were left in the dental clinic he knew absolutely nothing about.

It is clear to me, as I'm sure it is to anyone else who is not blinded by the lies of Reece Daniel and the controlled local media, or possessed of a hateful, biased and prejudiced mindset against us, as are sycophant Reece Daniel and his gang of predatory armed thug terrorist Orwellian thought police, that this alleged building code violation would never have come about were it not for the unlawful, improper influence of Reece Daniel and his minions, in retaliation against Mr. Fox, myself, and our friends. Their publicly stated entire objective is to use the police power to utterly destroy Mr. Fox and his Matthew25Mission (his life's work for the Lord), and prevent our church group from having and using the legally acquired former Methodist Church building and property that Kathleen Stanfield wants for herself, in collusion and criminal conspiracy with Reece Daniel and his gang of armed thugs.

Sure, I have filed two law suits against the City and their insolent, corrupt, constitutionally disobedient police, but only after they gave me no other alternative with their incessant slanderous lies spewed forth in the local media against me and my friend, Robert James Fox, and committed their vicious armed, paramilitary attack against me, now proven to have been predicated by fraud of Reece Daniel and Jason Price, not just once, but now twice.

In parting Jody, and I say this to all other City officials, just as I said in my first letter, you need to eradicate the evil miscreants from your police employees who perpetrate and perpetuate such evil wickedness, such as Reece Daniel, Jason Price, John Page, Travis Cearley, and Daniel Franklin, and possibly others. Perhaps y'all think your general practice, policy and custom of such totalitarian socialist police state communism, and fascist feudalism is appropriate city policy, but if you examine the Holy Bible and Constitution of the United States of America, I'm sure you'll find such general practice, policy, and custom as has been executed against me, Robert James Fox, and our friends, is also against our Creator/Savior and His Laws, and undermining the State and U.S. Constitutions in the nature of sedition and treason against the very people you purport to serve in your capacities as public servants. Once again, I inform you all it is our sincere hope the City of Jacksonville will cease and desist its senseless persecutions against us and honor and respect our rights to be the honorable and beneficial men we are and always have been, and always will be for the betterment of

society and the people whom we serve, in service to our Creator/Savior by sacred covenant.
