This page, Item A1 is for information purposes. The subject matter of this section is about a new Conveyor's Information Card [C.I.C.] which after twelve years of usage of the old C.I.C., I determined that improvements were necessary at this time.

Items A2 and A3 are a two page letter to certain individuals which I believed needed to receive 'notice and service' of these changes. This is to insure 'openness', 'record', 'accountability', and 'fun'[on my behalf]. This letter is rather straight forward and I should think needs no discussion.


Item A4 is an enlargement of the C.I.C., for ease of reading as what is photocopied (from letter) is in actual size [2.125 h. x 3.375 w inches] for ease of reading.

Items A5, A6, and A7 are the usual proofs of delivery, service, and receipt. Do note one item is different than the others. This is actually good so that people can be aware of a back-up if a certain problem occurs.

Discussion about Conveyor's Information Card:

1. Both the old and new C.I.C.'s are on notice letter[Items A2 and A3] . The actual size of the old C.I.C., was 3.75 h. x 3.50 w. in inches. The new size is the same as a regular driver's license[credit card] so it fits in a wallet much nicer. Only had a copier to use 12 years ago to make the old one.
2. One will notice that the address is different on the old and the new: see discussion in this Appendix under address -old and new – as a repeat discussion on this subject will not be included here.
3. The format of the new card is similar in many aspects of the driver's license used here in Arkansas with those which desire to have a contract with MAMMON. This includes placement of picture, signatures, state shape and color, text location, and so forth.
4. The C.I.C. # is of some pleasure to me. As one can see the center of the card has the 7-pointed star with the seven stars in color; hence the # begins with “7stars”. The “00” is relative to a nick-name which had been given to me in the past by some 'older' builders and construction workers. One might think about 00 buckshot. The # “13” is relative to the date on which I was born; and, that same number has other meanings to me. Twelve tribes plus THE CHRIST; Nehemiah is standing in the center with 7 priests on his left and 6 priests on his right (7+6=13) – Neh. 8:4; 12 Apostles + THE CHRIST.
5. The 7-pointed star with the 7 stars in color is especially appreciated by me. My many thanks to both of the individuals which did that work with such precision. Obviously, the 7 stars is of great interest to me: “The mystery of the seven stars which thou sawest in my right hand[THE CHRIST'S hand]...” - Rev. 1:20. Please note the section in this Appendix about 'stars' if you would like some free copies to download.
6. This I get a 'kick!' This I think is 'cute!' This I think is 'fun!' On the normal driver's license there is an area at the bottom for statistics and such. Please see where 'endorsements' is located and this is a real section of regular licenses in this state. **Well, what would be more appropriate for me then to have it known that I endorse THE FATHER'S LAWS? Should not everyone? I LOVE IT!**
7. Also, there is an area on the Babylonian driver's license which has an area for 'restrictions' such as having to wear glasses and such. Well, with some imagination, what would be **better** than pointing out to the world and all of the 'others' that I am **restricted** from MAMMON. - “Ye can not serve God (THE FATHER) Mammon.” - Matt. 6:24 – THE CHRIST speaking.
The color used for MAMMON was as close to 'pink' as I could get and still have the color show up okay. I really wanted a 'bright pink'.
P.S. - I am of the opinion the Babylonians actually or at least desire to weak 'pink panties' – and that's my story **AND I am sticking to it!**
8. Did you notice the expiration date: '2050' which should give me plenty of time before I need to make a new one unless I learn some more. One might want to review certain sections in The Gathering/Offering Course and look at certain Constructive Notices and Requirements to Perform; maybe see a case about what is required for identification relative to the citation process. One might want to look under 'Ford Van'/pages 5&6/item 9/ long quote/People v. Monroe.
9. The rear side of this card should be simple to understand. However, the simple will **not** look up the quoted verses, take it to heart, and begin a new life.

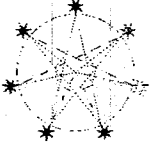
