

Chapter 6 - Man's Laws; Are they valid? Are they anti-Christ?

- B) 'Those which fail to study history are doomed to repeat it'. -  
A Short Look at the Constitution of the United States!

In the process of learning it becomes important to accomplish research. Failure to understand the causes as to why events occur always places the individual and the group in a high-risk position of ultimate failure with respect not only to the current issue at discussion(problem), but, also to future issues(problems). In other words, foundational errors in one area can cause total failure in multiple areas.

It is also nice that the learning, even after the fact of error, that in many cases a recovery, full, can be obtained with the individual or group learning of their error and their admission of their error. In 1995, on my first 'Notorious Declaration', Chap. 3, Part A, page 7 of this Offering, I stated that "I am a Soverin Citizen of the United States. Further, I stated on page 3-2 of Chap. 3, Part B, 'People of the state are entitled to all the rights which formally belonged to the King by his prerogative.' - Lansing v Smith, 21D. 89 (1829). And, further, I used the terminology of sovereign in other fashions. THIS WAS IN ERROR! I did not even type the 'word' correctly in my first useages.

'Soverign' - (according to Webster's Dictionary Unabridged, 1968 and additionally copywrited back to 1904), #1 - above or superior to all others; chief; greatest; supreme.  
#2 - supreme in power, rank, or authority, etc.

I bought into this in error because I read the 'political' definition which placed me into direct contradiction to THE FATHER's 1st LAW - "I am the Lord thy Everliving(God)...Thou shalt have no other gods before me." I was in error from the beginning. Certainly, I am not superior, nor am I the greatest, nor am I a chief, nor am I supreme, nor am I supreme in power, rank, or authority, etc.. 'Hook, line and sinker did I swallow; and, I gag on my error.

I bought into 'Lansing v Smith'. I bought into the political definition!

The Treaty of Paris which is attached in this Part B was not a focus in my research because the copy which I 'had' or 'used' only had the ten(10) Articles in my original copy. That copy left-off the first approx. 450 words; and, I only desired to read Article 1. I only desired to prove what I thought I knew.

Lansing v Smith was a court decision which said I had the 'rights of the King' and that I was the same as him(the King). In the first sentence of the Treaty of Paris the rights of the King are deliniated for all to see.

These rights are what he owned. What he gave to us which choose to be 'sovereign'. What we own if we are 'sovereign'. What we have 'bought' into if we are sovereign.

Refer to Treaty of Paris for following:

- 1) 'most potent Prince George' --So now I am a 'prince'?  
Gen. 23:6 - "...thou art a mighty prince among us." - spoken by Caininites to Abrashem with Abrashem refusing to rebuke Caininites for using said term about him. Fenton Bible says 'like a god'. Thomson Bible says 'art a king from God'. The caininites 'elevated' Abrashem and he failed to rebuke them.

Gen. 32:28 - KJB, "...as a prince hast thou power with God...".  
F. Fenton Bible says "...for you have wrestled with a Divine Messenger as with men, and been equal to it(the task?)." Col. Thomson says "...enabled to prevail with God, therefore with men thou shalt be mighty."

Am I a prince? Are you a prince? Have we been 'set-up' by the 'words' (usage) in the King James Bible?

- 2) 'duke of Brunswick and Luneburg' - So now I am a 'duke'?  
Gen. 36:1 & 15 - "Now these are the generations of Esau who is Edom. & "These were dukes of the sons of Esau:...". F. Fenton says 'chiefs'. Col. Thomson says 'emirs'.

Am I a duke? Are you a duke? Do we really want to be a 'son of the sons of Esau'?

- 3) 'arch-treasurer' - So now I am the treasurer? Of what, the Holy Roman Empire. You may read this yourself! Do YOU NOW HAVE THE ANSWER as to why you are paying 'income taxes'? One pays income taxes to supply the Holy Roman Empire which is the 'Whore of Babylon': which is the Universal Catholic Church(U.C.C. as in Uniform Commercial Code).
