For the record, Me, I am a man. I am not a corporation, intending to become one, nor an officer or a surety for one. I am competent to make informed decisions in this matter. I do not understand this matter and I demand to know who does. If I am here at all I am here in special appearance. I do proceed sui juris.

For the record, In manner of a "Lanier notice" (United States v. Lanier, on certiorari No. 95-1717) I hereby notice this court and all interested parties that I will be accessing the Constitution for the united States of America and \_\_\_\_\_ Constitution. By Law I am to be presumed innocent at all time!

- ✓ I am vested with a 5th amendment right to refuse to testify against myself.
- ✓ I am vested with a 1st amendment right to remain silent, and conversely, to say whatever I please.
- ✓ I am vested with the right to refuse to explain why I decline to testify.
- ✓ I am vested with a 6th amendment right to effective assistance of counsel.
- ✓ I am aware that I vested with a Griffin right to due process of law at all stages of this prosecution. Griffin v Illinois, 100 L Ed 891, 351 US 12, 76 S Ct 585, 55 ALR 2nd 1055 (1965) holds that everybody is entitled to Due Process at every stage of the proceeding - and a free transcript, too.
- ✓ Griffin , supra, holds that everybody is entitled to Due Process at every stage of the proceeding. Due Process is defined, in part, as including notice and meaningful opportunity to be heard. This, in turn, means adequate time to prepare. The 6th and 1st amendments guarantee effective assistance of counsel and the right to associate and petition for redress.
- ✓ I demand a withdrawal of any alleged plea; it was given without counsel. An Attorney is not counsel; he is representation. A judge is not qualified to be one's representation. I do not need somebody to take my place. I need assistance - effective assistance - just like the 6th amendment promises.
- ✓ I demand all discovery before I make a plea. I simply do not understand the nature and cause of the accusation with regard to the elements of personal jurisdiction, venue, underwriting and nature of the action until the prosecution properly alleges and certifies them. Therefore I am unable to make a plea. I do make timely challenge to the jurisdiction of this court.
- ✓ I demand to see the original affidavit in support of the alleged warrant.
- ✓ I demand that no business on my case be transacted in chambers. **No ex parte.**

- ✓ I demand a copy of all discoverable documents including police reports and all files regarding me and this matter be produced immediately.
- ✓ I demand certified copies of the charging affidavit, application for the warrant and of the warrant both for my use and duly placed into evidence. Lacking these items it does appear that there is an attempt of fraud upon this court.
- ✓ Let it be known that I waive no rights. I do claim and reserve all rights, remedies, defenses, statutorial or procedural, and I retain full constitutionally secured rights, power, privileges and prerogatives and enjoy the benefits thereof, at all times - in all places. I do, however, waive [the] benefit privilege.
- ✓ Taking notice of and considering the 13<sup>th</sup> amendment to the Constitution of the united States of America and considering that this court is advertising Admiralty jurisdiction by the display of that gold fringed flag and pursuant to Uniform Commercial Code (UCC) § 3-501, without dishonor, let it be known that I am not in possession of nor am I aware of any originating contract or manner of contract or agreement existing that in any way compels me (the man) to any manner of performance, regarding this captioned and docketed matter, or that binds me to the jurisdiction of this court, this state, and/or the alleged THE STATE OF \_\_\_\_\_.
- ✓ I demand a competent and functioning court reporter whenever I am in court.
- ✓ I demand a prompt (within 5 working days) transcript of each hearing. I demand an **MSWord version** of every transcript. If you don't have MSWord then **html, MSWord .doc, txt, rtf, or editable pdf** format may be acceptable.
- ✓ I demand a competent and lawfully qualified jurist (judge) at all times. Not an administrator.
- ✓ I cannot pay the costs of this litigation.
- ✓ I demand a fair trial at a fair pace with a fully informed jury.
- ✓ If you are attempting to get me to act as surety for some artificial entity which has a 'name' similar to what I go by then let it be known that I am keeper of records that may pertain to that entity and with immunity I will be happy to state to what I am aware of concerning it.
