

Declaration of Rights of Wesley-David: family of Bowden and  
**Notice of Crime to the Judge of the Court as required by law**

"I, Wesley-David: family of Bowden<sup>1</sup>, declare pursuant to the Texas Bill of Rights which protects the rights of Wesley-David: family of Bowden as stated in Article 1, Section 3<sup>2</sup>, and 29 herein related, of the Texas Bill of Rights:

PROVISIONS OF BILL OF RIGHTS EXCEPTED FROM POWERS  
OF GOVERNMENT TO FOREVER REMAIN INVIOULATE.

"To guard against transgressions of the high powers herein delegated, we declare that everything in this "Bill of Rights" is excepted out of the general powers of government, and shall forever remain inviolate, and all laws contrary thereto, or to the following provisions shall be void."

"Without a verified contract<sup>3</sup> in evidence before the grand jury, the civil, political, and religious rights of the pagan artificial commercial person known as the Defendant WESLEY DAVID BOWDEN have been violated. And further, I, Wes Bowden, a Christian man, also without contract in evidence, was kidnapped, and placed in involuntary servitude, and without contract I was imprisoned by inland pirates, IRS agent, Jay Mason, Assistant U. S. Attorney, Sarah R. Saldana, and the Grand Jury which was given false information, and like all dairy cows given bad feed, regurgitated the mendacities they were fed by Mason and Saldana as indicated by the irregular and void indictment. Under color of law, I was kidnapped and imprisoned under the pretense that there was a law, 26 USC 7201, that I had violated. 26 USC 7201 has no implementing regulation for Texas and therefore has no force of law. In addition, 26 USC 7201 is for federally privileged workers and does not have jurisdiction over me because I am not a federally privileged worker. The labor of Wes Bowden, which I exchange without profit income for equal value services with other people in Texas, is not a commodity or an article in interstate commerce<sup>4</sup>.

"Without verified contract, my rights have been denied because I have been forced into a foreign court by deceptive trade practices, threat, duress, and coercion. So far I have been denied the right of a common law grand jury comprised of people not obligated to the court<sup>5</sup> who know the difference between fact and fiction, and a trial by law by jury in a competent court as the Article 5, Section 15 superior court of record of common law pleas in the county of Dallas, Texas. Prior to judgment in a civil case,<sup>6</sup> there is no law allowing the kidnapping of me, Wes Bowden.

"All color of law and adhesion contracts to the contrary of the above are un-enforceable, null and void on its face.
