The letter to the Postmaster, Item A2, is simple in it's form. I choose to employ[use] each of the words which are enclosed[typed] of said letter. Others which add or subtract certain other words may be smarter than I am as I have only been doing this for twelve (12) years, with no problems.

The proof(s) are listed by photocopy on Item A3. This is the return receipt card[color is green which does not show up (the color) on my copier] has been sent back to me by the United States Postal Service via '**post**'. I do not use 'mail'! The address which I use is a '**post**' **location address**. It is simple to see that my 'new 7 line address' is the text on the receipt card. It is simple to see that the signature side of the card shows a signature of receipt. Further, one can see that the certification #, which is on letter to the Postmaster, is on this receipt card.

Notice: **I do not use the form which is supplied by the Post Office, with free 'mailing', to accomplish this task!** One might want to think about this a minute. Okay?
